RESOLUTION FOR THE TOWNSHIP OF BRICK, COUNTY OF OCEAN, STATE OF NEW JEREY AUTHORIZING RETAINER AGREEMENT WITH MOTLEY RICE, LLC FOR OPIOID LITIGATION

WHEREAS, the Township of Brick has been battling the opioid addiction problems in our town through both aggressive law enforcement and education and treatment programs for addicts; and

WHEREAS, the Mayor and Township Council are fully committed to pursuing all avenues and options to address the major concerns caused by addiction to opioids, including heroin and similar drugs; and

WHEREAS, as part of these continuing efforts, the Mayor has recommended to the Township Council that the national law firm of Motley Rice, LLC be engaged, on the terms set forth in the Retainer Agreement, on file in the Township Clerk's Office, to file a lawsuit against the companies that manufacturer opioids, based on misrepresentations by such companies about the addictive properties of opioid drugs; and

WHEREAS, said Retainer Agreement provides that Motley Rice, LLC shall receive no payment of any kind from the Township unless and until a recovery is received from such litigation, upon which Motley Rice LLC shall be entitled to a percentage of such recovery; and

WHEREAS, the Retainer Agreement with Motley Rice, LLC is deemed a "professional services" contract within N.J.S.A. 40A:11-5; and

WHEREAS, the Township Attorney has reviewed said Retainer Agreement and recommends its acceptance to the Township Council.
