1.     **OWNER:**               Township of Brick
2.     **WORK TITLE:**       Brick Township Public Works Yard  
                                  Vehicle Storage & Fuel Station Canopy Improvements

4.     **WORK DESCRIPTION:**

**The major work items include furnishing, delivering and erecting three (3) steel canopy structures along with forming and pouring reinforced concrete spread footings and piers, with associated electrical and site work.**

5.     **CONTRACT DOCUMENTS:**

A certificate is required from a surety company stating that it will provide bonds in the form and amounts as stated in the Contract Documents.
