**NOTICE TO BIDDERS** hereby is given that Bids are invited and will be received as set forth below.

1. **OWNER: Township of Brick**
2. **WORK TITLE: 2018 Pavement Markings, Various Locations**
3. **WORK SITE: Various Locations throughout the municipality including but not limited to Greenbriar Adult Community, Shore Acres, Baywood, Birchwood Park, Seawood Harbor and Princeton Commons.**
4. **WORK DESCRIPTION: Construction of pavement markings, traffic lines, paint and thermoplastic at various locations in municipal roadways and public property.**
