**NOTICE TO BIDDERS** hereby is given that Bids are invited and will be received as set forth below.

1. **OWNER: Township of Brick**
2. **WORK TITLE: Drainage Improvements To Baywood**
3. **WORK SITES: Cadiz Drive, Monterey Drive, Valencia Drive, Alhama Drive, Cartagena Drive, and St. Lawrence Boulevard.**
4. **WORK DESCRIPTION: The project generally consists of drainage improvements to Cadiz Drive, Monterey Drive, Valencia Drive, Alhama Drive, Cartagena Drive, and St. Lawrence Boulevard in the Baywood section of the Township. Work in this project will include drainage improvements, concrete curb, and other associated work. Approximate construction quantities include 200 LF of 8" Ductile Iron Pipe, 360 LF of 12" Ductile Iron Pipe, 790 LF of 12" Reinforced Concrete Pipe, Class V, 50 LF of 15" Reinforced Concrete Pipe, Class V, 120 LF of 18" Reinforced Concrete Pipe, Class V, and other associated work.**

During the performance of this contract the Contractor agrees to comply with the requirements of P.L. 1975, c. 127 (N.J.A.C. 17:27), all requirements of the State of New Jersey Worker Health and Safety Act (N.J.A.C. 12:110 et seq.) as amended and the United States Occupational Safety and Health Act (OSHA) (29 CFR 1910), as amended with regard to worker and jobsite safety.

The Township reserves the right to increase or decrease quantities specified in the manner designated in the Specifications. The Township reserves the right to award this contract based on funds available.

## **16. BID WITHDRAWAL:**

The Bidder shall comply with the statutory requirements set forth in N.J.S.A. 40:A11-23.3 regarding bid withdrawal. The successful bidder will be required to furnish a surety company bond in the full amount of the contract price indemnifying the Township of Brick, New Jersey for all proceedings, suits or actions of any kind of description and conditional for the faithful performance of the work.

Owner reserves the right to reject any or all Bids and to waive any immaterial defect or informality in any Bid, if deemed in the best interest of the Owner.
