NOTICE TO BIDDERS hereby is given that Bids are invited and will be received as set forth below.

- 1. OWNER: Township of Brick**
- 2. WORK TITLE: Purchase & Delivery of 150-ft MONO-POLE**
- 3. WORK SITE: Drum Point Sports Complex, 301 Brick Boulevard, Ocean County, New Jersey**

4. WORK DESCRIPTION:
The major work items to be completed under the scope of this Contract consist of design, fabrication and delivery of a 150-ft steel mono-pole and associated mounting fixtures.
