ORDINANCE

CALENDAR YEAR 2019 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Council of the Township of Brick in the County of Ocean finds it advisable and necessary to increase its CY 2019 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Council hereby determines that a 3.5 % increase in the budget for said year, amounting to \$2,765,405.19 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Brick, in the County of Ocean, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Township of Brick shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 1.0%, bringing the percentage to 3.5% amounting to a \$790,115.77 increase, bringing the total to \$2,765,405.19 and that the CY 2019 municipal budget for the Township of Brick be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

**RESOLUTION**

**WHEREAS**, the Mayor and Township Council have received a request to waive the restrictions of the Township's noise ordinance, as set forth in Chapter 281 of the Township Code, from the Brick Township Municipal Utilities Authority, 1551 Route 88, Brick for the drilling of two observation wells on the BTMUA Water Treatment Plant Campus; and

**WHEREAS**, the request seeks a waiver to allow the contractor to drill wells continuously for 24 hours per day. Each well should take approximately four (4) weeks for a total of eight (8) weeks between April 1 and July 3, 2019. The BTMUA will be providing advance notice to nearby residents; and

**WHEREAS**, the Contractor will erect a sound barrier to reduce the impact to the neighboring residents; and

**WHEREAS**, the basis for the request is that performing the work 24 hours per day will allow construction to be completed prior to the summer season; and

**WHEREAS**, the Township Council therefore desires to memorialize in this Resolution a limited waiver of the noise ordinance, Chapter 281, for the dates and times set forth;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Brick, County of Ocean, State of New Jersey as follows:

**RESOLUTION OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING EXECUTION OF A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE COUNTY OF OCEAN FOR THE AWARD OF A HOMELAND SECURITY GRANT**

**WHEREAS**, the State of New Jersey, Office of Homeland Security and Preparedness, has awarded the Township a grant for the purchase of SCUBA equipment in the amount of \$9,315.00; and

**WHEREAS**, the Homeland Security Grant program is run through the Ocean County Sheriff's Office for approved purchases; and

**WHEREAS**, a condition of the award of the grant to the Township is the entry into a Memorandum of Understanding with the County of Ocean (MOU), which provides for the requirements for acceptance of the grant by the Township; and

**WHEREAS**, the Township Council now desires to authorize the Mayor to execute the MOU with the County of Ocean on file in the Municipal Clerk's Office, subject to the terms and conditions of this Resolution and the provisions of the Memorandum of Understanding;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Brick as follows:

1. That the Township Council hereby authorizes the Mayor to execute, and the Municipal Clerk to attest to the Memorandum of Understanding between the Township and the County of Ocean, which provides for the requirements for the Homeland Security Grant to the Township in the amount of \$9,315.00 for the purchase of SCUBA equipment.
2. That the MOU shall be in full force and effect until July 31, 2020 or until such time all funds have been exhausted and all obligations met.
3. That the Municipal Clerk shall forward a certified copy of this Resolution to the County of Ocean.

AN ORDINANCE OF THE TOWNSHIP OF BRICK,  
COUNTY OF OCEAN, STATE OF NEW JERSEY  
AMENDING THE TOWNSHIP CODE OF THE  
TOWNSHIP OF BRICK ARTICLE XXXVI. SIGNS, TO  
DELETE §245-313C

WHEREAS, by Ordinance adopted June 27, 2017, the Township Council of the Township of Brick amended § 245-313 captioned "Signs", and authorized the issuance of municipal permits for the temporary use of flags, streamers, banners and sandwich boards by commercial establishments; and

WHEREAS, Ordinance provided for the sections authorizing the issuance of permits for flags, streamers, banners and sandwich boards to expire as of December 31, 2018 unless extended by further action of the Township Council; and

WHEREAS, the Township Council of the Township of Brick believes it is appropriate to make the provisions of § 245-313 authorizing the issuance of permits for flags, banners, streamers and sandwich boards permanent.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Council of the Township of Brick, County of Ocean, and State of New Jersey, as follows:

SECTION 1. § 245-313C be and is hereby deleted.

SECTION 2. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 3. This ordinance shall take effect after second reading and publication as required by law.
