NOTICE TO BIDDERS hereby is given that Bids are invited and will be received as set forth below.

- 1. OWNER: Township of Brick**
- 2. WORK TITLE: Whitman Street Phase II – Culvert & Embankment Repairs**
- 3. WORK SITE: Whitman Street (Greenbriar Subdivision)**

4. WORK DESCRIPTION:

The major work items to be completed under the scope of this Contract consist of invert repair, fiber-reinforced concrete lining of culvert, and restoration and replacement any disturbed embankment areas.

5. CONTRACT DOCUMENTS:
