

RESOLUTION

WHEREAS, sealed bids were received by the Division of Purchasing and Contracting of the Township of Brick for Purchase and Delivery of Flood Control Valves on Tuesday, June 30, 2020; and

WHEREAS, the bids have been reviewed by the Township Engineer; and

WHEREAS, the Township Engineer has recommended award of said bid to the lowest responsive and responsible bidder being in full compliance with the bid specifications.

NOW, THEREFORE, BE IT RESOLVED THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN AND STATE OF NEW JERSEY, as follows:

1. That the contract for Purchase and Delivery of Flood Control Valves is hereby awarded to Wapro, Inc., 150 North Michigan Avenue #1959, Chicago, IL 60601 as per the attached schedule of prices.
2. That this will be a two (2) year contract commencing on July 15, 2020 and ending on July 14, 2022.
3. That this is a unit price bid not to exceed \$200,000.00 for the contract period with funds to be certified prior to each purchase. Sufficient funds are available under Ordinance #8-20, account C-04-55-870-404.
4. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
5. That a certified copy of this resolution shall be forwarded to the vendor, Business Administrator, Chief Financial Officer, Township Engineer and the Purchasing Agent.
