

RESOLUTION

WHEREAS, N.J.S.A. 19:44A-20.5 et seq. provides for the procedure for soliciting proposals through a fair and open process; and

WHEREAS, there is a need to retain Veterinary Services for emergency/minimal care for sick and /or injured dogs, cats or wildlife; and

WHEREAS, the Township of Brick has solicited proposals for said service through a fair and open process on November 13, 2020; and

WHEREAS, the Business Administrator has reviewed the proposals and is satisfied with the qualifications of the firms which are the subject of such an award; and

WHEREAS, the Business Administrator recommends award to Cedars Veterinary Hospital, LLC and Jersey Shore Veterinary Emergency Service Corp.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Brick, County of Ocean and State of New Jersey, as follows:

1. That the contract for Veterinary Services is hereby awarded to the following veterinary facilities at the rates as indicated on "Attachment A" with an aggregate not to exceed amount of \$20,000.00:
 - Cedars Veterinary Hospital, LLC, 120 Drum Point Road, Brick, NJ 08723
 - Jersey Shore Veterinary Emergency Service Corp., 1000 Rte 70 E, Lakewood, NJ 08701
2. That this contract is being awarded as a professional service in accordance with N.J.S.A. 40A:11-5 pursuant to a fair and open process.
3. That this contract is awarded contingent upon the adequate provisions of funding in the 2021 operating budget under appropriation entitled Animal Control Expenses, account T-12-56-866-302.
4. That this resolution shall take effect January 1, 2021 for duration of one (1) year.
5. That the Mayor is authorized to execute and the Township Clerk to attest to the agreements and such agreements shall be available for public examination in the office of the Township Clerk during normal business hours.
6. That a notice of this action shall be printed once in the official newspaper of the Township of Brick.
