Township Clerk Iannarone thanked everyone for participating in this evening's Township Council meeting. She said the COVID-19 pandemic prevents them from meeting in the traditional way, but they have adjusted accordingly so that they can continue to conduct the business of the Township, and serve the residents. This meeting began with the salute to the flag followed by a moment of silence.

Township Clerk Iannarone called for nominations for Council President.

Mayor Ducey administered the oath of Council President to Lisa Crate.

Township Clerk Iannarone presented the gavel to Council President Lisa Crate.

President Crate called for nominations for Council Vice President.

Councilman Mummolo nominated Councilman Arthur Halloran as Council Vice President.

Motion by Councilman Minichino and seconded by Councilwoman Zapcic to nominate Councilman Arthur Halloran as Council Vice President.

There were no other nominations.

All Council Members voted AYE on Roll Call to elect Councilman Arthur Halloran as Council Vice President.

January 5, 2021

Mayor Ducey administered the oath of Council Vice President to Arthur Halloran.

President Crate introduced Mayor John G. Ducey for opening remarks.

Mayor Ducey said last New Years Day he stood in this room and asked for 2020 to be a year of "Unity" here in Brick. He asked the residents to work together no matter the side of town, no matter the age and no matter the different background. He said at that time, no one realized what was in front of all of us and no one realized exactly how much they would ultimately have to unify and work together to get through the worst possible scenario of 2020. He said they all have experienced, witnessed and certainly have heard of sickness, death, financial ruin, social chaos, isolation and many other things occurring around the country and across the world. He said here in the town they had to and continued to have to do what they do which is serve the public – not an easy thing to do in 2020. He said first is an obligation to the taxpayers financially and to that end 60 employees furloughed and they did so selflessly to help co-employees and help residents by helping the towns budget. He said the employees who stayed at work selflessly worked harder than ever doing jobs of two or three others or risking their own health to keep the services of the town going. He said services that reached record highs for a number of things: the most leaves ever put out to the curb, the most ever gun permits ever applied for, the most storm debris ever put to the curb, the most bulk pick-ups, the most season beach badges ever sold, the most wellness calls to seniors ever made, the most recycling/garbage cans ever sold, the most calls to Code Enforcement, and the most food deliveries made. He said they had to adapt to the times and come out of the comfort zone and offer so many variations of the Township's known services and noted all of them. He said they also continued with normal activities as best they could and completed Bayside Park, Brick Beach III parking lot, Drum Point turf field, had an environmental engineering firm create a short term and long-term plan for the flooding in parts of the Township, paved \$2M of roads, testified before a Senate committee about school funding, Trader Cove concerts, Farmers Market, held four neighborhood flood mitigation meetings, held summer camp and kept man of the various fall events and annual ceremonies going. He said the whole Township was brought together by the 12-year-old Brick Little League winning the NJ State Championship and giving all happiness and pride as the town celebrated them with a great parade to honor their awesome achievement. He said the town came together and ordered take out and delivery, had volunteers picking up food from grocery stores and delivering to those who were sick, without transportation or susceptible to catching the virus, residents promoting small business on social media, community groups offering services to help feed residents, keep them in homes and help them pay for utilities and other needs. He said remember that 2020 was the year when we all rediscovered a spirit of togetherness, of community, of unity – it was the year in which Brick Township kept moving forward in the biggest crisis ever faced for most of our lifetimes. He said now the theme for 2021 is "Hope" Hope for Health, Hope for Covid-free, Hope for economic recovery, Hope for that the good of 2020 can remain with us...saying hello to strangers on the street while walking, eating dinner at home with family, playing board games, thanking police and EMS and volunteer fire and truck drives and grocery workers and teachers and DPW workers, maintenance and factory workers, nurses and doctors and all others who continued to work outside their home away from families and comfort zones. He said Hope and knowledge that Brick is unified and continue to be the best town in the country – 2021 is the year of "Hope".

President Crate opened the public hearing portion of the meeting.

Robert Palmisano, 525 Broad Avenue, stated his displeasure that his emails have not been answered by Administration regarding the flooding; he stated that work trucks are cruising through the streets in Normandy Beach causing havoc with the water and causing a huge wake and it is damaging personal property; he said several residents have requested police sit on Broad Avenue instead of the corner of 7th and Broad because they are not doing any good there to slow down vehicles; he asked for an update on the flapper valves and the locations they are installed; he spoke and stated his displeasure with the water coming up through the catch basins; he questioned what monies are being budgeted in the 2021 budget for additional flapper valves and flood remedies in Normandy Beach.

Mayor Ducey gave an update on the flapper valves; he advised they are looking into what the best remedy for the catch basins to make them waterproof; he gave an update on the funding for flapper valves; he said they received good news a grant in the amount \$450,000.00 from NJDOT in the joint application with Toms River and addition to that the 2021 Capital Budget will include the funding for the rest of the projects while they apply for other grants as well.

Mr. Palmisano ~~said that he is not satisfied~~ said that he is not satisfied ~~tated his displeasure~~ with the length in time these projects are taking.

Bill C, Resident of Brick, said he was interested in volunteering on a committee.

President Crate asked for the resident to send an email of interest to the Mayor.

Catherine, Broad Avenue, stated her concerns with the overwhelming of flooding and the damage that it has caused to their property; she echoed Mr. Palmisano comments on the disregard for property damage that the flooding has caused by the vehicles causing wakes and asked for that issue to be addressed and mentioned she has called the police with this issue but received no response.

Mayor Ducey responded the police are definitely the way to go they are the ones that respond to all emergencies in town including flooding and said they always have an officer that patrols on the Barrier Island and he will pass this issue along to the Chief.

Vice President Halloran questioned if there are any designations of where these vehicles/trucks are coming from.

Mr. Palmisano advised he sent pictures to the Mayor and Administrator.

Jim Muller, Normandy Beach Resident, spoke and stated his concerns with the flooding and advised it is "urgent" and the last two days they could not drive in and out of Broad Avenue.

Jeanne McCurdy, 527 Broad Avenue, stated her concerns with the damaging flooding/wakes the commercial vehicles are making – if there was someone who could just stop some of this traffic; she ~~said that she is not satisfied~~ said that she is not satisfied ~~tated her displeasure~~ with length of in-time these projects are taking and not getting answers to her emails.

Mr. Muller added to Mrs. McCurdy comments.

Mr. Palmisano stated his displeasure with ACT Engineers and reiterated his previous comments on the flapper valves and catch basins.

Eileen Marano, 548 Broad Avenue, spoke and stated her concerns with their home being flooded and damaged on a daily basis; she said every time the road is flooded and a truck of any significant size drives down the street her garage gets flooded and that includes the police hummer because it is such a heavy truck; she questioned if there is a process for visiting medical personnel if they park their vehicle where there is no flooding would someone be able to pick them up and drive them to their patient.

Mayor Ducey said the Township's emergency management coordinator sends emails letting the Normandy Beach group know when the high tides are coming and advised to call 911.

There was extensive discussion between Mr. Palmisano, Mrs. McCurdy and Mrs. Marano on the wakes the contractor/commercial vehicles are causing and the need for a police officers to stop this kind of traffic.

There were no further comments from the public.

President Crate closed the public hearing portion of the meeting.
