

**RESOLUTION**

**WHEREAS**, sealed bids were received by the Division of Purchasing and Contracting of the Township of Brick for Uniforms for Various Departments on Friday, June 11, 2021; and

**WHEREAS**, the bids have been reviewed by the Purchasing Agent; and

**WHEREAS**, the Purchasing Agent has recommended the award of said bid on a per item basis to the lowest responsive and responsible bidder.

**NOW, THEREFORE, BE IT RESOLVED THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN AND STATE OF NEW JERSEY, AS FOLLOWS:**

1. That the contract for the purchase and delivery of Uniforms for Various Departments is hereby awarded to the following vendors in accordance with the attached schedule of prices:
  - Concept Print, 40 Lydecker Street, Nyack, NY 10960
  - Dot Designing, LLC, 242 Possum Hollow Road, Monroe Township, NJ 08831
  - Keyport Army and Navy, P.O. Box 985, Brick, NJ 08723
2. That this is a unit price contract not to exceed \$50,000.00 per year with funds to be certified prior to each order. Sufficient funds are available in 2021 budget and pending adoption of the 2022 and 2023 budgets under appropriations entitled Roads – Uniforms, account 1-01-26-290-224; Maintenance of Parks – Uniforms, account 1-01-28-375-224; Code Enforcement – Uniforms, account 1-01-22-195-224; Recreation – Uniforms, account 1-01-28-370-224; Police – Uniforms, account 1-01-25-240-224; Engineering – Uniforms, account 1-01-20-165-224; Land Use – Uniforms, account 1-01-21-181-224.
3. That this is a two (2) year contract commencing on July 24, 2021 and ending on July 23, 2023 with prices that shall remain firm fixed.
4. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
5. That a copy of this resolution shall be forwarded to the vendors, Business Administrator, Chief Financial Officer, Director of Recreation, General Supervisor, Public Works, Deputy Chief of Police, Human Resources Director and the Purchasing Agent.
