

## INVITATION TO BID

**NOTICE TO BIDDERS** hereby is given that Bids are invited and will be received as set forth below.

1.     **OWNER:**                   Township of Brick
2.     **WORK TITLE:**        **BRICK POLICE DEPARTMENT SPECIAL OPERATIONS BUILDING & VEHICLE STORAGE**
3.     **WORK SITE:**         401 Chambers Bridge Road, Brick, NJ 08723
4.     **WORK DESCRIPTION:**

The major work items include furnishing, delivering and erecting one (1) steel building structure, forming and pouring all reinforced concrete spread footings and piers, and various site works items. The contractor will also install all utilities and fit-out the interior office space.

An add-alternate Bid Option is included, consisting of the complete task of building a 2800 s.f. interior office space within this new steel building, including electric, heat, A/C, communications, finishes, doors, windows, etc.

5.     **CONTRACT DOCUMENTS:**

Contract Documents may be examined, and/or purchased at a fee of **\$30.00**, Monday through Friday, except legal holidays, from 9:00 A.M. to 4:00 P.M., prevailing time, at the Township of Brick. Cash is accepted and all checks are to be made out to Township of Brick. Credit card payments are acceptable in-person only.

6.     **USE OF CONTRACT DOCUMENTS:**

Contract Documents are available solely for the purpose of obtaining Bids and not to confer a license or grant for any other purpose.

7.     **PRE-BID MEETING:**       None

8.     **BID GUARANTEE:**

Bid Guarantee is required in an amount not less than ten percent (10%) of the total amount indicated in the Bid, but not in excess of Twenty Thousand Dollars (\$20,000).

9.     **CONSENT OF SURETY:**

A certificate is required from a surety company stating that it will provide bonds in the form and amounts as stated in the Contract Documents.
