

RESOLUTION

WHEREAS, sealed bids were received by the Division of Purchasing and Contracting of the Township of Brick for Ambulance Repairs on Tuesday, July 20, 2021; and

WHEREAS, the bids have been reviewed by the General Supervisors, Public Works, Deputy Chief of Police and Safety Inspector; and

WHEREAS, the General Supervisor, Public Works, Deputy Chief of Police and Safety Inspector hereby recommend award of said bid to the lowest responsive and responsible bidder being in full compliance of the bid specifications.

NOW, THEREFORE, BE IT RESOLVED THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN AND STATE OF NEW JERSEY, as follows:

1. That the contract for Ambulance Repairs is hereby awarded to PL Custom Body & Equipment Co., Inc., 2201 Atlantic Avenue, Manasquan, NJ 08736 with a labor rate of \$95.00 per hour and 0% discount on parts for Auto Mechanical Repairs, Life Support Components, and Body Repairs.
2. That this will be an open-ended contract not to exceed \$100,000.00 per year with funds to be certified prior to each service. Sufficient funds are available in 2021 budget and pending adoption of the 2022 and 2023 budgets under appropriations entitled Vehicle Maintenance, accounts 1-01-26-315-206 and 1-01-26-315-262.
3. That this is a two (2) year contract commencing on September 11, 2021 and ending on September 10, 2023.
4. That the labor rate and percentage on parts shall remain firm fixed for the duration of the contract.
5. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
6. That a copy of this resolution shall be forwarded to the vendor, Business Administrator, Chief Financial Officer, General Supervisors, Public Works, Police Chief, Director of EMS, Safety Inspector and Purchasing Agent.
