## Discussion Points

This section summarizes each discussion point addressed during the meeting.

## Public Input

### Surveys

Mr. Huch provided an update on the Township’s survey responses.

- Public Survey: As of 9/2/21, there have been 240 responses.
- Business and Commerce Survey: As of 9/2/21, there have been 6 responses.
- Emergency Services Survey: As of 9/2/21, there has been one response.
- Repetitive Loss Area Analysis: As of 9/2/21, there have been 22 responses. This number will increase as direct mailings take place to the properties located in the newly aligned repetitive loss areas.

Mr. Huch noted that the review of new survey responses showed that identified floodprone locations and suggested actions mirrored previous survey responses which the Planning Committee had discussed at the last meeting.

Ms. Weaver asked if surveys will remain open and if residents who have experienced basement flooding from high water table should submit surveys. Mr. Huch explained that high water table impacts are briefly included in the urban flooding section of the Risk Assessment. The survey will

remain open through the start of the draft plan public review period, until the first reading for Town Council.

### ***CRS Reverification***

Ms. Paxton explained that the Township's CRS review is nearly complete, pending the submission of the FMP and the RLAA.

Mr. Huch explained there are also numerous appendices that are currently in development that will be posted for steering committee review when available. These appendices include information on references, meeting agendas and notes, and the plan adoption resolution.

The Planning Committee decided that review of the plan will be done via OneDrive. Mr.Huch will send a link and instructions for review to the Committee. Planning Committee review will take place for a period of one week. The plan will then be posted for Public Review for one month.

During Public Review, the plan can be sent to ISO for review. At the conclusion of the Public Review, the plan will be submitted to the Town Council for adoption.

### ***Plan Maintenance***

The Planning Committee agreed to meet quarterly to review the progress of the FMP and maximize available CRS points.
