

**RESOLUTION**

**WHEREAS**, sealed bids were received by the Division of Purchasing and Contracting of the Township of Brick for Tree Trimming, Removal and Disposal Services on Friday, January 7, 2022; and

**WHEREAS**, the bids have been reviewed by the Superintendent of Public Works; and

**WHEREAS**, the Superintendent of Public Works has recommended the award of said bid to the lowest responsive and responsible bidder being in full compliance with the bid specification.

**NOW, THEREFORE, BE IT RESOLVED THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN AND STATE OF NEW JERSEY**, as follows:

1. That the contract for Tree Trimming, Removal and Disposal Services is hereby awarded to Falkinburg Tree Expert Company, P.O. Box 688, Brielle, NJ 08730 as per the attached schedule of prices.
2. That this will be an open-ended contract not to exceed \$20,000.00 per year with funds to be certified prior to each service. Sufficient funds are available pending adoption of the 2022 and future budgets under an appropriation entitled Maintenance of Parks – Tree Removal Service, account 2-01-28-375-293.
3. That this will be a two (2) year contract commencing on January 29, 2022 and ending on January 28, 2024.
4. That all pricing shall remain firm fixed for the duration of the contract.
5. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
6. That a copy of this resolution shall be forwarded to the successful bidder, the Business Administrator, Chief Financial Officer, Superintendent of Public Works and the Purchasing Agent.

<b>Stumps</b> – extract, remove, and backfill all hazardous stumps greater than forty-eight inches (48") and above in diameter and place debris on private/public property or ROW. Backfill shall be flush with the surrounding ground with compatible material. Grinding stumps in place is only acceptable with prior written approval under this pay item.	\$425.00 / per stump
Removing, hauling, disposing and recycling of eligible vegetative debris to an authorized recycling facility, including limbs and trees placed on ROW.	\$9.50 / per cubic yard
