

INVITATION TO BID

NOTICE TO BIDDERS hereby is given that Bids are invited and will be received as set forth below.

1. **OWNER:** Township of Brick
2. **WORK TITLE:** Nejecho Lagoon Dredge and Windward Beach Nourishment Project
3. **WORK SITE:** Nejecho Lagoon and Windward Beach
4. **WORK DESCRIPTION:** Mechanical dredging of 2,190 cubic yards of material from Nejecho Lagoon. The dredge material is to be managed and transported to Windward Beach where it will be dewatered. Dewatered material is to be placed and graded onto Windward Beach.
5. **CONTRACT DOCUMENTS:**

Contract Documents may be examined, and/or purchased at \$5.00 per set, Monday through Friday, except legal holidays, from 9:00 A.M. to 4:00 P.M., prevailing time, at the OWNER's address. A certificate is required from a surety company stating that it will provide bonds in the form and amounts as stated in the Contract Documents.
