

## RESOLUTION

**WHEREAS**, sealed bids were received by the Division of Purchasing and Contracting of the Township of Brick for General Athletic Equipment & Supplies on Wednesday, June 29, 2022; and

**WHEREAS**, the bids have been reviewed by the Superintendent of Recreation; and

**WHEREAS**, the Superintendent of Recreation has recommended award of said bid to the lowest responsive and responsible bidder being in full compliance with the bid specifications.

**NOW, THEREFORE, BE IT RESOLVED THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN AND STATE OF NEW JERSEY, as follows:**

1. That contract for General Athletic Equipment & Supplies for the catalog percentage discount is hereby awarded to the following vendors as per Attachment A:

2. That this is a unit price bid, therefore, funds shall be certified prior to each order, with a total not to exceed amount of \$50,000.00 per year. Sufficient funds are available in 2022 budget and pending adoption of the 2023 and 2024 budgets under appropriation entitled Recreation Rider account T-03-56-862-267.
3. That this will be a two (2) year contract commencing on July 15, 2022 and ending on July 14, 2024.
4. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
5. That a certified copy of this resolution shall be forwarded to the vendors, Business Administrator, Chief Financial Officer, Superintendent of Recreation and Purchasing Agent.
