

RESOLUTION

WHEREAS, N.J.S.A. 40A:11-4.3 et seq. requires the procurement of certain specialized goods and services through a competitive contracting process; and

WHEREAS, on August 9, 2022, the Township Council adopted a resolution authorizing the utilization of competitive contracting procedures for the procurement of Ambulance Administration Services/EMS Billing (EMS Billing and Collection Services); and

WHEREAS, sealed proposals in accordance with the competitive contract process pursuant to N.J.S.A. 40A:11-4.1 et seq. and N.J.A.C. 5:34-4.1 et seq. were received by the Division of Purchasing and Contracting on April 25, 2023; and

WHEREAS, the award of a competitive contract proposal shall be made to the respondent whose proposal is the most advantageous to the Township, price and other factors considered; and

WHEREAS, the proposals have been reviewed and ranked by the Evaluation Committee and the Committee has deemed Coronis Health RCM LLC, to be the highest ranked proposal; and

WHEREAS, the Evaluation Committee recommends award to Coronis Health RCM, LLC.

NOW, THEREFORE, BE IT RESOLVED THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN AND STATE OF NEW JERSEY, as follows:

1. That the Proposal most advantageous to the Township, price and other factors considered has been submitted by and hereby awarded to Coronis Health RCM LLC, 50-US Highway 9N, Building B, Morganville, NJ 07751 at a cost to the Township of 7% on the return of bills.
2. That this award is for two (2) years, commencing June 14, 2023.
3. That this award is permitted for a maximum of five (5) years and the Township reserves the right to renew or rebid the contract for years three (3), four (4) and five (5).
4. That all terms, rates, percentages, guarantees and offers shall remain firm fixed for the duration of the contract.
5. That a notice of this action shall be printed once in the official newspaper of the Township of Brick.
6. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
7. That a copy of this resolution shall be forwarded to the vendor, Business Administrator, Chief of Police, Chief Financial Officer and Purchasing Agent.
