- 1) All fire lanes and fire access and areas must remain open and accessible at all times.
- 2) NJDOT Permit needs to be submitted prior to the event for any portion of Rt. 35 impacted.
- 3) The hiring of Special Law Enforcement Officers should be considered to assist with the number of projected attendees/runners.
- 4) Runners shall not impede the normal flow of traffic on Rt. 35 and no pavement markings are to be made on any travel lanes of Rt. 35. It is recommended that the race take place in the bike lanes on Rt. 35 and not the vehicle travel lanes.
- 5) Applicant will provide an adequate number of sanitary facilities (bathrooms) for the number of persons present and will be responsible for the cleanup of such.
- 6) The intentional and/or accidental release of balloons and other helium/gas filled objects into the atmosphere is environmentally detrimental and should be prevented.
- 7) Issuance of a special events permit does not relieve the applicant from complying with permits required under other New Jersey statues or municipal ordinances including, but not limited to, construction permits required under the Uniform Construction Code NJAC 5:23 or permits required under the Uniform Fire Code N.J.A.C. 5:70.

ORDINANCE

AN ORDINANCE OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE IN SECTION 288-52 TO ADD LOCATIONS FOR THE POLICE DEPARTMENT TO ENFORCE MOTOR VEHICLE REGULATIONS ON PRIVATE PROPERTY

WHEREAS, when the owner of property located outside of a public right-of-way desires to authorize the Police Department to enforce the provisions of Title 39 of the New Jersey Statutes, which pertain to motor vehicle laws, on such property, the owner must request authorization; and

WHEREAS, the sites set forth below have applied to the Township for authorization of Title 39 enforcement in private property areas; and

WHEREAS, the sites have all been inspected by the Division of Engineering to ensure that traffic signs and markings are properly installed in accordance with the Manual on Uniform Traffic Control Devices (MUTCD); and

WHEREAS, this ordinance will authorize the police to enforce motor vehicle regulations, but the Township will have no liability or obligation for site maintenance;

NOW THEREFORE, BE IT ORDAINED by the Mayor and Township Council of the Township of Brick, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Chapter 288 of the Township Code of the Township of Brick entitled "Vehicles and Traffic" is hereby amended in Section 288-52 entitled "Private Areas," to add the following locations, in an appropriate alphabetical location:

WHEREAS the property will remain subject to a deed restriction providing the Township of Brick with a right of first-refusal on any sale during the control period and the option to purchase the property at the expiration of the control period at the maximum allowed restricted sale price at the time;

SECTION 1. The Township is the owner of real property known as Block 842, Lots 14, 14.01 and 15, located at 1701 Route 88.

SECTION 5. The closing on the sale of the property shall occur upon Homes Now, Inc., obtaining all necessary approvals to develop the property in accordance with the terms of this Ordinance. Homes Now Inc. shall have a period of two years from adoption of this Ordinance to close on the sale of the property.
