

RESOLUTION

WHEREAS, sealed bids were received by the Division of Purchasing and Contracting of the Township of Brick for Ambulance Repairs on Tuesday, August 29, 2023; and

WHEREAS, the bids have been reviewed by the Superintendent of Public Works, Deputy Chief of Police and Safety Inspector; and

WHEREAS, the Superintendent of Public Works, Deputy Chief of Police and Safety Inspector hereby recommend award of said bid to the lowest responsive and responsible bidder being in full compliance of the bid specifications.

NOW, THEREFORE, BE IT RESOLVED THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN AND STATE OF NEW JERSEY, AS FOLLOWS:

1. That the contract for Ambulance Repairs is hereby awarded to Larson Ford, Inc., 1150 Ocean Avenue, Lakewood, NJ 08701 for Auto Mechanical Repairs, Life Support Components, and Body Repairs at the labor rates and discounts on Attachment A.
2. That this will be an open-ended contract not to exceed \$100,000.00 per year with funds to be certified prior to each service. Sufficient funds are available in 2023 budget and pending adoption of the 2024 and 2025 budgets under appropriations entitled Vehicle Maintenance, accounts 3-01-26-315-206 and 3-01-26-315-262.
3. That this will be a two (2) year contract commencing on September 13, 2023 and ending on September 12, 2025.
4. That the labor rate and percentage on parts shall remain firm fixed for the duration of the contract.
5. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
6. That a copy of this resolution shall be forwarded to the vendor, Business Administrator, Chief Financial Officer, Superintendent of Public Works, Deputy Chief of Police, Director of EMS, Safety Inspector and Purchasing Agent.
