

RESOLUTION

WHEREAS, the Division of Purchasing and Contracting received sealed bids for the Purchase and Delivery of Automated Garbage Cans on Friday, August 11, 2023; and

WHEREAS, the bids have been reviewed by the Superintendent of Public Works; and

WHEREAS, the Superintendent of Public Works, has recommended award of said bid to the lowest responsive and responsible bidder being in full compliance with the bid specifications.

NOW, THEREFORE, BE IT RESOLVED THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BRICK, COUNTY OF OCEAN AND STATE OF NEW JERSEY, as follows:

1. That the contract for the purchase and delivery of Automated Garbage Cans is hereby awarded to Rehrig Pacific Company, 1738 West 20th Street, Erie, PA 76502 at the following rates:
 - 95 Gallon Containers – \$59.57 – model 95 Gallon Enviroguard – 95 Gallon Nestable Bar
 - 65 Gallon Containers – \$52.78 – model 65 Gallon Enviroguard – 65 Gallon Nestable Bar
 - 35 Gallon Containers – \$48.25 – model 35 Gallon Enviroguard – 35 Gallon Metal Bar
2. That this is a unit price bid with not to exceed amount of \$150,000.00 per year; therefore, funds shall be certified prior to each order. Sufficient funds are available in 2023 budget and pending adoption of the future budgets under an appropriation entitled Solid Waste Collection – Equipment Recycling, account 3-01-26-305-267.
3. That this will be a two (2) year contract commencing on September 13, 2023 and ending on September 12, 2025.
4. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
5. That a certified copy of this resolution shall be forwarded to the vendor, Business Administrator, Chief Financial Officer, Superintendent of Public Works, and the Purchasing Agent.
