

INVITATION TO BID

NOTICE TO BIDDERS hereby is given that Bids are invited and will be received as set forth below.

1. **OWNER:** Township of Brick
2. **WORK TITLE:** Bay Harbor Estates Roadway Improvements
3. **WORK SITE:**
 - (a) Base Bid: Queen Ann Road, Eastland Road, Glen Road, Lime Road, Orange Road, Bimini Road, Appleton Road, Hemlock Road, Acapulco Drive, Beaumont Drive, Homewood Drive, Clearwater Drive, Somerset Drive, and Claremont Drive.
 - (b) Add Alternate - A: Queen Ann Road, Fontainebleau Drive, Sunnydale Drive, Brookfield Drive, and Greenville Drive.
 - (c) Add Alternate – B: Queen Ann Road, Ardmore Drive, Lawndale Drive, and Bay Way.

4. **WORK DESCRIPTION:**

The major work items to be completed under the scope of this Contract consists of roadway milling and resurfacing.

5. **CONTRACT DOCUMENTS:**

8. **BID GUARANTEE:**

Bid Guarantee is required in an amount not less than ten percent (10%) of the total amount indicated in the Bid, but not in excess of Twenty Thousand Dollars (\$20,000).

9. **CONSENT OF SURETY:**

A certificate is required from a surety company stating that it will provide bonds in the form and amounts as stated in the Contract Documents.
