2. That this contract shall not exceed \$950,000.00 per year and funds shall be certified prior to services being rendered. Sufficient funds are available under an appropriation entitled Snow Removal Rider, account T-03-56-870-302.
3. That the term of this contract shall be for an initial term of two (2) years ending on November 10, 2025 the option to renew for a third year and all hourly rates per vehicle shall be firm fixed for the duration of the initial contract.
4. That the Mayor is hereby authorized to execute and the Clerk to attest to the proposed form of agreement aforesaid, which such agreement shall be available for public examination in the office of the Township Clerk during normal business hours.
5. That a certified copy of this resolution shall be forwarded to the vendor, Business Administrator, Chief Financial Officer, Superintendent of Public Works and the Purchasing Agent.
