NOTICE TO BIDDERS hereby is given that Bids are invited and will be received as set forth below.

1. **OWNER: Township of Brick**
2. **WORK TITLE: Roadway Improvements to Pinewood Drive - 2022**
3. **WORK SITE: Pinewood Drive & Red Bluff Road**
4. **WORK DESCRIPTION: Roadway Resurfacing with appurtenant improvements to Pinewood Drive and Red Bluff Road.**
5. **CONTRACT DOCUMENTS:**

Contract Documents may be examined, and/or purchased at \$15.00 per set, Monday through Friday, except legal holidays, from 9:00 A.M. to 4:00 P.M., prevailing time, at the OWNER's address. 8. **BID GUARANTEE:**

Bid Guarantee is required in an amount not less than ten percent (10%) of the total amount indicated in the Bid, but not in excess of Twenty Thousand Dollars (\$20,000).

9. **CONSENT OF SURETY:**

A certificate is required from a surety company stating that it will provide bonds in the form and amounts as stated in the Contract Documents.
