NOTICE TO BIDDERS hereby is given that Bids are invited and will be received as set forth below.

1. **OWNER: Township of Brick**
2. **WORK TITLE: 2024 Pavement Markings, Various Locations**
3. **WORK SITE: Various locations throught the municipal streets and public complexes including but not limited to, Greenbriar, Greenbriar II, Princeton Commons, the Municipal Complex, Civic Plaza Parking Lot, Brick Beach 1 Parking Lot, Brick Beach 3 Parking Lot, The Drum Point Sports Complex Parking Lots, Wedgewood, Duquesne Boulevard and Laurelton Gardens.**
4. **WORK DESCRIPTION: Construction of pavement parkings, traffic lines, painted or thermoplastic symbols at various locations on municipal roadways and public property.**
